## **Investment Philosophy & Approach**

The Fund seeks capital appreciation. The Fund pursues its goal by investing at least 80% of its net assets (including borrowing, if any) in the common stocks of U.S. companies in the financial services sector. The Fund may invest in companies of any size, but, under normal conditions, the Fund invests primarily in small capitalization stocks.

# Seek companies that appear to have the following characteristics:

- Strong management, sound financial practices, and a defensible business niche
- Focus on firms with sustainable growth in earnings, revenue, and cash flow
- Identify undervalued equities that are temporarily distressed and have merger and acquisition potential



Investment Terms: **Annualized Rate of Return** is the geometric mean return of the portfolio calculated for a one-year period. Standard Deviation measures volatility risk, or how closely returns track their long-term average. **Active Share** is a measure of the percentage of stock holdings in a manager's portfolio that differs from the benchmark index. **Turnover Rate** or Turnover Rate is the percentage of a mutual fund or other portfolio's holdings that have been replaced in a 12-month period. **Weighted Average Market Capitalization** refers to a type of stock market index construction that is based on the market capitalization of the index's constituent stocks; large companies would, therefore, account for a greater portion of an index than smaller stocks.
