- The RMB Funds listed above are expected to pay capital gain distributions on December 13, 2022, to all shareholders of record as of December 12, 2022. The price for each fund distributing capital gains will be adjusted downward on the business day following the record date to reflect the amount of the distribution.
- The RMB SMID Cap Fund listed above paid and early dividend and capital gain distribution on November 7, 2022, to all shareholders of record as of November 4, 2022.
